Thank you for your email of 8th February 2021 where you requested the following information:

*Could I please ask BEIS to confirm:*

- 1. whether they received any representation from (a) Sutton Liberal Democrats, (b) Sutton Council, (c) Councillor Jayne McCoy, (d) Sutton Decentralised Energy Network or (e) Viridor to the consultation entitled "Heat networks: building a market framework"; and,*
- 2. whether they received any correspondence from the same above mentioned organisations/persons between 12th December 2019 to 8th February 2021 regarding the Beddington "energy from waste" (incinerator) facility and/or the New Mill Quarter housing development in Hackbridge; and if they will share the contents?*

Under the Freedom of Information Act 2000 ('the Act'), you have the right to:

- know whether we hold the information you require
- be provided with that information (subject to any exemptions under the Act which may apply).

Please find below responses to each of your questions:

- 1. Whether BEIS received any representation from (a) Sutton Liberal Democrats, (b) Sutton Council, (c) Councillor Jayne McCoy, (d) Sutton Decentralised Energy Network or (e) Viridor to the consultation entitled "Heat networks: building a market framework"?*

BEIS did not receive direct representation from Sutton Liberal Democrats, Sutton Council, Councillor Jayne McCoy, Sutton Decentralised Energy Network or Viridor in our *Heat networks: building a market framework* public consultation.

*2. Whether BEIS received any correspondence from the same above mentioned organisations/persons between 12th December 2019 to 8th February 2021 regarding the Beddington “energy from waste” (incinerator) facility and/or the New Mill Quarter housing development in Hackbridge; and if they will share the contents?*

BEIS did not receive any correspondence from the abovementioned organisations or persons between 12<sup>th</sup> December 2019 and 8<sup>th</sup> February 2021 regarding the Beddington waste incinerator or the New Mill Quarter housing development in Hackbridge.
